Thank you for your interest in the scholarship program at Pacifica Graduate Institute. The average scholarship range is \$500-\$5,000 per academic year. These funds are applied toward tuition in equal installments over the fall, winter, spring and summer quarters for which you are enrolled in full-time coursework (6 units).

Application materials must be completed and returned with supporting documentation to the Financial Aid Office by the deadlines listed below. Late and/or incomplete applications will not be considered.

Newly admitted students – Fall 2008: deadline August 1, 2008
Returning students: deadline June 15, 2008

Pacifica Scholarships are not automatically renewed, and prior recipients, although encouraged to apply, are not guaranteed a continued award. Only the Board of Trustee Scholarship is renewable provided recipients meet the required 3.5 cumulative grade point average. Students enrolled in the thesis or dissertation phase of their program are not eligible for consideration.

To qualify you must complete the following by the deadlines listed above:

1. New applicants must be accepted to an eligible program at Pacifica by August 1 and continuing students must be enrolled full-time in coursework (6 units) at Pacifica.
2. Submit a brief essay with your application. Be sure to convey in your essay:
 - any extenuating financial circumstances that you feel should be considered;
 - express your goals and objectives;
 - your plans for the future;
 - how the scholarship monies will help you realize your goals.
3. Complete the 2008-09 FAFSA form (www.fafsa.ed.gov). Results must be on file in the Pacifica Financial Aid Office by deadlines listed above.
4. International Students must also complete the International Scholarship Addendum according to deadlines listed above.

A Scholarship Committee will review the scholarship application, essay and FAFSA results. Recipients will be selected based on high financial need, academic merit and the content of the essay.
