2. Submit a brief essay with your application. Be sure to convey in your essay the following:
  - a. Any extenuating financial circumstances that you feel should be considered;
  - b. Express your goals and your plans for the future;
  - c. Explain how the scholarship funds will help you obtain your goals.
3. All scholarship materials (application, essay and 2019-2020 FAFSA results) must be received in the Financial Aid Office by the Deadline listed above. **International Students** must complete and submit the income information (page 2 of this application) in place of the FAFSA, by the deadline listed above along with the application and essay.
