RESEARCH ABSTRACT (approximately 4 pages)

The complete ethics application includes this PDF file with appropriate signatures and a Word document that contains a research abstract and three attachments. The research abstract describes:

□ TOPIC, QUESTION, and METHODOLOGY (1 page).

□ PARTICIPANTS: Who will participate (specify eligibility criteria), how many you are seeking, and how you will recruit and screen them. (half-page).

□ PROCEDURES: Informed consent procedures, data collection, and method of data analysis (1 page).

□ RISKS & SAFEGUARDS: Potential risks to participants, including the likelihood and seriousness of confidentiality breaches and how you will protect against them. (1 page).

□ BENEFITS: The benefits to be gained by the participants and/or society from the study (half-page).

INFORMATION FOR PARTICIPANTS (approximately 3 pages)

Create the following **three** items proposed to recruit, inform, and survey participants and append them to the abstract. Include any and all documentation pertaining to the study which will be shown to them.

□ The flyer, announcement, or other notification you will use to recruit participants.

 \Box The informed consent forms that fully explains to prospective participants the criteria for eligibility to participate, and the risks, safeguards, and benefits from participating in the study.

□ The research instruments to be used (e.g. questionnaire, survey, semi-structured interview guide or set of open-ended interview questions).

PROCEDURE

- 1. STUDENT: Complete form, generate required documents, and submit to Dissertation Chair.
- 2. CHAIR: Review documents, complete and sign form, and submit to Research Coordinator.
- 3. RESEARCH COORDINATOR: Review documents, complete and sign form, and email to dissertation@pacifica.edu.
