# **Pacifica's Story**

<u>Pacifica Graduate Institute</u> is an innovative and unique graduate school dedicated to its motto's expressed purpose: *animae mundi colendae gratia*—for the sake of tending soul in and of the world.

Pacifica's genesis was in response to the Vietnam War and the cultural upheaval of the 1970s. Concerned individuals in the university town of Isla Vista, California saw returning veterans, families, and young people in distress, so they gathered resources and developed a community counseling outreach program to aid those around them.

This community initiative, led by Founding President Steven Aizenstat, evolved into a graduate program in counseling psychology. What was then known as the Human Potential Movement influenced both the degree program and its founders. Following the push of the times and their calling, people attended workshops and trainings at the Esalen Institute in Big Sur, California and came to know Joseph Campbell, James Hillman, and the work of Marion Woodman. These pioneering thinkers frequently traveled to Santa Barbara and offered support as the school and its programs evolved. These mentors helped what was then The Human Relations Institute grow into Pacifica Graduate Institute — a respected and accredited graduate school firmly rooted in the traditions of Jungian and Depth psychology.

Today, the world is quite different, yet Pacifica's mission and purpose remain even more pertinent. With a lingering multiyear pandemic, marked by grief, social unrest, systemic racism, and ongoing gender inequalities and sexual harassment, the mental health needs of our world have never been greater.


# Faculty, Students, and Alumni

Almost 50 years later, Pacifica remains one of only a few graduate schools that provides students with a soul-centered "intelligence" integral to what is being asked of us now. Extending the concepts of psychology and mythological studies beyond the personal, the classroom, and the consulting room, we see psychological life as an evolutionary development within nature, alive in all the phenomena and systems of our world. In studying and working with these multidimensional exchanges, we facilitate contributions to the contemporary concerns of our world through dialogue among the psyche of the individual, the mythologies of the culture, the collective human imagination, and the living planet. Pacifica is dedicated to cultivating and celebrating the gifts of the human imagination establishing an educational environment that nourishes respect for cultural diversity and individual differences and an academic community that fosters a spirit of free and open inquiry.

A 32-member core and associate core faculty and 162 adjuncts teach approximately 800+ adult learners who participate in monthly, three-day on-campus learning sessions or study in programs that combine residential and hybrid learning options at Pacifica's two beautiful campuses in Santa Barbara County. An additional 400 students are enrolled in dissertations or thesis work. The PGI educational experience is informed by a one-of-a-kind basis in depth psychological understanding of the unconscious. We are grounded in C.G. Jung's understanding that the psyche is fundamentally connected with our soul experience. Staff, faculty, and alumni step up daily to support students' educational growth and personal transformation.

Students who graduate from Pacifica help to heal and change the lives of others and their communities. Many receive degrees to work as therapists, counselors, psychologists, entrepreneurs, coaches, and more. Others use their education in mythology or other areas to imagine and create a better future for all of us. Today, over 5,000 active alumni carry out the institution's motto: *Animae mundi colendae gratia* – for the sake of tending soul in and of the world.

# **Ninety Miles North of Los Angeles**



The Santa Barbara area has many charms that enrich students' experiences — from the Pacific Ocean with its broad, sandy beaches, and the coastal foothills to the town's Mediterranean architecture and its many cultural, dining, and entertainment offerings.

Both Pacifica Campuses have been designed and carefully maintained with special consideration for their beautiful settings. <u>Pacifica's Lambert Road Campus</u> is on the restored and expanded former site of a philanthropist's 1920's-era estate. The campus is graciously shaded by large oaks and sycamores with soulful pathways and inspiring views of the Pacific Ocean and the Santa Ynez Mountains.

A short drive from its sister campus on Lambert Road, <u>Pacifica's Ladera Lane Campus</u> has a retreat center, classrooms, administrative offices, the Graduate Research Library, and the Pacifica Bookstore. The OPUS Archives and Research Center's rare collections are housed on this campus. Residential buildings offer lodging for students when classes are in session and healthy meals are shared in the large communal dining hall. Spacious lawns present views of the Pacific Ocean, Santa Barbara, Channel Islands, and surrounding Santa Ynez Mountains. Gardens, fountains, and wooded pathways allow quiet contemplation and conversation.

Landscaping and people paths are arranged to invite the birds, insects, and other animals of the area to make their homes in these places. Gardens and orchards on the properties are cultivated with organic methods, moving Pacifica closer to its goal of environmental sustainability.

# Opportunities and Expectations for Leadership

The Provost fosters a culture of shared governance, promoting inclusive and equitable decision-making processes that value diverse perspectives. Overall, the Provost's participation extends to nearly all facets of academic life, underpinning Pacifica's commitment to academic excellence, innovation, collaboration, and care of the soul. The Provost is also a member of the executive leadership team.

### Core Responsibilities

- Academic Vision: Provides the academic vision and direction of the Institute to Pacifica Graduate Institute members, including, but not limited to, the Board, the President & CEO, administrators, faculty, staff, students, and alumni openly and communicatively and serves as the leader for the Institute's academic mission by contributing to the long-term vision and strategic plan with a focus on academic excellence.
- Faculty Excellence: Oversees and advocates for an effective process of diverse faculty recruitment, hiring, retention, evaluation, support, and promotion in psychology with emphasis on Depth and Jungian Psychology. Ensures faculty members receive the support they need to carry out academic excellence inside and outside the classroom and uphold Pacifica Graduate Institute's mission and values. The provost will also serve as a member of the faculty.
- Student Success: Oversees various programs to ensure student success from enrollment to graduation to alumni status. Works closely with faculty to learn about student needs in the classroom to help students and faculty become more effective in their learning approaches and teaching styles. Collaborates with departments to make the student-to-alumni experience more engaging

- and resourceful. Work with the Vice President of Enrollment to increase efforts in recruiting more diverse students interested in depth psychology to make depth psychology accessible to all people.
- Budgeting and Financial Resources: Establishes the Institute's priorities for budgeting, resource projections, and analysis supporting the academic mission. Works closely with the Chief Financial Officer to guide a culture of financial (and academic) integrity and data analysis.
- *Community*: Serves as the chief academic spokesperson for the Institute on regional, national, and international networks. Builds rapport with the Pacifica Graduate Institute community and creates deeper partnerships locally in Santa Barbara, as well as globally through strategies such as the Pacifica SOUL Promise. Has an important and deep understanding of what *personally tending the soul in and of the world means*.

- If the candidate's background is not in academia but in psychology, at least seven years of experience working in a psychological practice, with an emphasis in Depth Psychology.
- Demonstrated commitment to scholarship through publications and conference presentations.
- Excellent track record of developing rapport and building relationships with administrators, faculty, students, and other key stakeholders.
- Experience developing programs and writing books, best practices, and policies in higher education, psychology, faculty excellence, or student success.

- Has an innovative, collaborative, entrepreneurial, and respectful leadership approach when carrying out Pacifica Graduate Institute's mission and values.
- Outstanding written and oral communication skills and adept at making presentations at various events at the Institute and beyond.
